## PUBLIC NOTICE

### **PREFERENTIAL PROCUREMENT REGULATIONS 2011**

Buffalo City Metropolitan Municipality would like to advise all its suppliers that the Minister of Finance Hon Pravin Gordhan has issued new regulations in terms of section 1 (111)(f) of the Preferential Procurement Policy Framework Act, 2000 (Act No. 5 of 2000). The effective date of the regulation is **7<sup>th</sup> December 2011**.

In terms of the new regulation, all suppliers are required to claim preferential points against a recognised B-BBEE status level of contribution. In order to acquire a B-BBEE certificate, suppliers must be verified by the SANAS Accredited Verification Agencies as appearing on the Department of Trade and Industry and SANAS website respectively.
