1. PURPOSE

4. BACKGROUND

Section 53 (1) © of the MFMA, states that:

" the Mayor of a municipality must take all reasonable steps to ensure -

(ii) that the municipality's service delivery and budget implementation plan is approved

by the mayor within 28 days after the approval of the budget; and

(iii) that the annual performance agreements as required in terms of section 57 (1)(b) of

the Municipal Systems Act for the municipal manager and all senior managers –

(aa) comply with this Act in order to promote sound financial management;

(bb) are linked to the performance objectives approved with the budget and to the service delivery and budget implementation plan."

Furthermore, section 53 (3) stipulates that:

"the Mayor must ensure that the revenue and expenditure projections for each month and service delivery targets and performance indicators for each quarter, as set out in the SDBIP are circulated or made public no later than 14 days after approval of the SDBIP."

5. EXPOSITION OF FACTS

Service Delivery and Budget Implementation plan (SDBIP) guides the city in implementing the Integrated Development Plan and hold us accountable to residents of our metro. It also seeks to ensure monitoring and gives effect to the budget, performance of senior management and achievement of the service delivery objectives set by council. SDBIP enhances the principle of democratic and accountable local government as enshrined in section 152 of the Constitution of the Republic of South Africa.

BCMM Integrated Development Plan and Budget for 2024/2025 was adopted by the Council on the 31 May 2024 and section 53 of the MFMA regulates that the Executive Mayor must APPROVE the SDBIP after approval of budget.

6. CHALLENGES

The institutional readiness, limited budget and capacity challenges compromise the comprehensive implementation of all circular 88 addendums.
