- Original/certified BBEE Certificate
- CSD supplier number
- CIDB-proof of registration.

**NB: As per the National Treasury Regulations, prospective bidders must be registered on the Central Supplier Database prior submitting their bid proposal.**

Bidders are notified that payments of tenders be made at respective BCMM paypoints before collection of documents at SCM and also, prio payments bidders are to collect tender stubby at SCM for payment purposes.

**The institution will comply with the regulations set out on Level 4 of Lockdown of Disaster Management Act of 2020 in case of public bid openings or any other Level which will be applicable at the time of the opening.**

**By hand:** One original documents sealed tenders endorsed on the envelope with the **Bidder's name and address and the contract number** must be deposited in the **Formal Tender Box, Supply Chain Management Unit, 80 Phillip Frame Road, Chiselhurst, East London.**

**OPENING OF TENDERS:** Tenders will be opened in public at **14h00 on the 06 August 2021**, at Supply Chain Management Unit, No. 80 Phillip Frame Road, Chiselhurst.

Standard tender conditions will apply. Council reserves the right not to accept the only or lowest or any tender at all, or to accept the whole or part of any tender. The invitation and award of bidders is subject to the Council's Procurement Policy on tenders. The Council gives preference to previously disadvantaged contractors as set out in the procurement formula in the tender documents. Suppliers can only claim preferential points against a recognised B-BBEE status level of contribution. Canvassing of Councillors or Municipal Officials shall disqualify a tender.

The Council reserves the right to extend the tender period by a notice in the press. All contracts will be subjected to risk assessment, including presentation or interviews with service providers.
