# 1.1 GENERAL CONDITIONS OF THE REQUEST FOR QUOTATIONS (RFQ)

# BIDDERS ARE REQUIRED TO FAMILIARISE THEMSELVES WITH THE TENDERING CONDITIONS AND PROCEDURES AS DOCUMENTED BELOW.

- 1. For the purposes of this RFQ document, the words 'bidder' and 'tenderer', and 'RFQ' and 'tender' shall bear the same meaning.
- 2. 'BCMM,' where referred to in this document means Buffalo City Metropolitan Municipality'.
- 3. No quotation will be considered unless submitted on this RFQ document.
- 4. The whole original RFQ document, as issued by BCMM must be submitted. A quotation will be considered invalid and will not be accepted, if any part of this RFQ document is not submitted.
- 5. Bidders must submit one RFQ offer only, either as a single tendering entity or as a member of a joint venture.
- 6. Telephonic, telegraphic, telex, facsimile or emailed RFQ submissions will not be accepted.
- 7. Any portion of the RFQ document not completed will be interpreted as 'not applicable'. Notwithstanding the afore-going, failure to complete any compulsory portion of the RFQ document will result in the RFQ submission being declared non-responsive.
- 8. **Quotations must be properly received and deposited, on or before the closing date and on or before 11:00am**, in the <u>Informal Tender Box</u> at the BCMM Supply Chain Management Unit ('SCMU') situated at 80 Phillip Frame Road, Chiselhurst, East London. If the quotation submission is too large to fit in the allocated box, please enquire at the reception for assistance.
- 9. BCMM accepts no responsibility for ensuring that quotations are placed in the correct tender box, and should a quotation be placed in the incorrect tender box, it will be not be accepted.

#### 10. BCMM reserves the right to accept:

- 10.1 the whole quotation or part of a quotation or any item or part of any item, or to accept more than one quotation (in the event of a number of items being offered), and BCMM is not obliged to accept the lowest or any quotation;
- 10.2 a quotation which is not substantially or materially different from the RFQ specifications.
- 11. BCMM shall not consider quotations that are received after the closing date and time, as specified in the RFQ advertisement.
- 12. BCMM will not be held responsible for any expenses incurred by bidders in preparing and submitting quotations.
- 13. BCMM may, after the RFQ closing date, request additional information or clarification of submitted quotations, in writing.
- 14. A quotation may be rejected as non-responsive if the bidder fails to provide any clarification requested by BCMM within the time for submission stated in the written request for such clarification.
- 15. A bidder may request in writing, after the closing date, that its quotation be withdrawn. Such withdrawal will be permitted or refused at the sole discretion of BCMM after consideration of the reasons for the withdrawal, which shall be fully set out by the bidder in such written request for withdrawal.
- 16. The RFQ document must be signed by a person duly authorised to do so.

- 17. Quotations submitted by joint ventures, consortia, partnerships shall be accompanied by a joint venture, consortium, partnership agreement, in which it is defined precisely the conditions under which the joint venture, consortium or partnership will function, its period of duration, the persons authorised to represent and obligate it, the participation of the several firms of which it is formed, and any other information necessary to permit a full appraisal of its functioning.
- 18. Once the RFQ is awarded, all purchases will be made through an official BCMM Purchase Order. Therefore no goods must be delivered or services rendered before an official Purchase Order has been forwarded to the successful bidder. The successful bidder must then deliver or render service upon receiving an official signed Purchase Order from BCMM.

#### 19. Evaluation of RFQs

- 19.1 Quotations will be evaluated in accordance with the evaluation criteria set out in the Special Conditions of the Request for Quotations.
- 19.2 Quotations will be evaluated for price and preference using the 80/20 preference points system as follows –

Price	80
Specific Goals	20

- 19.3 Unless otherwise stated in the Special Conditions, a contract will be concluded with the bidder who complies with the evaluation criteria, and scores the highest total price, BBBEE and locality points.
- 19.4 Bidders may quote with or without VAT depending upon whether or not they are VAT vendors. In the calculation of price points, VAT shall be removed from the quotation amount of bidders who are registered as VAT vendors, so that financial offers can be evaluated on a comparative basis as a price advantage cannot be afforded to bidders who are not VAT vendors.

#### 20. Test for Responsiveness

#### 20.1 Invalid Submissions

Quotations shall be invalid if:

- (a) The quotation submission is not sealed when submitted into the tender box.
- (b) The quotation submission is not completed in non-erasable ink.
- (c) The form of offer has not been completed.
- (d) The bidder has been listed on the National Treasury's Register for Tender Defaulters in terms of the Prevention and Combating of Corrupt Activities Act, No. 12 of 2004, or has been listed on the National Treasury's List of Restricted Suppliers and who is therefore prohibited from doing business with the public sector.
- (e) The bidder is prevented from doing business with BCMM in terms of Regulation 38 and 44 of the Supply Chain Management Regulations (MFMA).

#### 20.2 Non-responsive Submissions

Quotations will be declared as non-responsive and eliminated from further evaluation in the following circumstances –

- (a) The submission has not achieved the minimum score for functionality as set out in the evaluation criteria, where functionality is applicable.
- (b) Where there are material deviations or qualifications to the RFQ which in BCMM's opinion would
  - (i) Detrimentally affect the scope, quality or performance of the works, services or supply identified in the scope of works;

- (ii) Significantly change BCMM's or the bidder's risks and responsibilities under the contract, or
- (iii) Affect the competitive position of the bidder, or other bidders presenting responsive submissions, if it were to be rectified.
- (c) The submission will be declared non-responsive if the bidder fails to adhere to a written request (within the specified period set out in such request) to
  - (i) Comply with the general conditions applicable to RFQs as contained in the BCMM Supply Chain Management Policy;
  - (ii) Complete and/or sign any declarations and/or authorisations;
  - (iii) Submit items 2 3 of the list of returnable documents in Part 2 (section 2.1) of this bid document.
- (d) The bid will be declared non-responsive in the event that the bidder's tax matters, as verified on the government Central Supplier Database, are shown not be in order, and the bidder fails to ensure that its tax matters are in order within such timeframe as may be required by BCMM in writing.

#### 21. Clarification of quotation after submission

The bidder must provide clarification of its submission in response to a request to do so from BCMM during the evaluation process. This may include providing a breakdown of rates or prices and correction of arithmetical errors by the adjustment of certain rates or item prices (or both). No change in the competitive position of bidders or substance of the submission may be sought, offered, or permitted.

#### 22. **Provide other material**

The bidder shall provide, on request by BCMM, any other material that has a bearing on the RFQ submission, the tenderer's commercial position (including notarized joint venture agreements), or samples of materials, considered necessary by BCMM for the purpose of a full and fair risk assessment. Should the bidder not provide the material, or a satisfactory reason as to why it cannot be provided, by the time for submission stated in BCMM's request, BCMM may regard the RFQ submission as non-responsive.

#### 23. Inspections, tests and analysis

The bidder shall, at the request of BCMM, provide access during working hours to its business premises for any inspections, tests and analyses as required for the RFQ.

#### 24. Securities, bonds, policies, etc

If required, the bidder must submit for BCMM's acceptance before formation of the contract, all securities, bonds, guarantees, policies and certificates of insurance required in terms of the conditions of contract.

#### 25. BCMM supplier database

- 25.1 Bidders must be registered on the BCMM Supplier Database, or meet the listing criteria set out in the BCMM Supply Chain Management Policy, in order to be considered responsive to the RFQ.
- 25.2 Bidders must be registered within 7 days of being requested to do so, failing which its submission shall be declared to be non-responsive.
- 25.3 It is each bidder's responsibility to keep all the information on the BCMM Supplier Database updated. If any information required (e.g. tax clearance certificate, CIDB certificate, etc) is not valid or has expired, all transactions with the vendor may, in the sole discretion of BCMM, be suspended until such time as the correct, verified information is received.

#### 26. Tax compliance status

- 26.1 No award shall be made to a person whose tax matters have not been declared to be in order by the South African Revenue Service (SARS).
- 26.2 Each party to a consortium, joint venture or partnership must comply with the above.
- 27. Declarations and authorisation

Bidders are required to complete all statutory declarations and authorisations in the schedules attached to this RFQ document, failing which the submission may be declared non-responsive.

#### 28. Samples

If the specifications require a bidder to provide samples, these shall be provided strictly in accordance with the instructions set out in the special conditions of the RFQ below.

#### 29. Alterations to tender document

Bidders may not make any alterations or additions to the RFQ document, except to comply with instructions issued by BCMM, or as are necessary to correct errors made by the bidder. All signatories to the RFQ submission shall initial all such alterations. Erasures and the use of masking fluid are prohibited.

#### 30. Objections, Complaints, Queries and Disputes / Appeals in terms of Section 62 of the Systems Act

#### 30.1 **Objections, complaints, queries and disputes**

Persons aggrieved by decisions or actions taken by BCMM in the implementation of the supply chain management system or any matter arising from a contract awarded in terms of the supply chain management system may, within 14 days of the decision or action, lodge a written objection or compliant or query or dispute against the decision or action.

#### 30.2 Section 62 Appeals

- (a) In terms of section 62 of the Systems Act, a person whose rights are affected by a decision taken by a political structure, political office bearer, councillor or staff member of a municipality in terms of a power or duty delegated or sub-delegated by a delegating authority, may appeal against that decision by giving written notice of the appeal and reasons to the Accounting Officer within 21 days of the date of notification of the decision.
- (b) An appeal shall contain the following:
  - (i) The reasons and/or grounds for the appeal;
  - (ii) The manner in which the appellant's rights have been affected;
  - (iii) The remedy sought by the appellant.

#### 30.3 Lodging of appeals, objections, complaints, queries and disputes relating to this tender

Appeals, objections, complaints, requests for information, queries and disputes must be submitted in writing to the Office of the Municipal Manager, 10<sup>th</sup> Floor, Trust Centre Building, Cnr of Oxford & North Streets, East London, OR by email, <u>amandag@buffalocity.gov.za</u>.

- 30.4 Additional objective criteria as per section 2(1)(f) of the PPPFA, will apply, as indicated in the tender document and which may include, but is not limited to:
  - Poor track record of the preferred bidder.
  - Unrealistic price offering which is not market related.
  - Unrealistic own conditions set by the bidder.

When using the list of accredited prospective providers the municipal manager must promote ongoing competition amongst providers, including by inviting providers to submit quotations on a rotation basis, unless differently specified during the procurement process.

# 1.2 SPECIAL CONDITIONS OF THE REQUEST FOR QUOTATIONS (RFQ)

The special conditions qualify, or are in addition to the general conditions in section 1.1 above. In the event of any ambiguity or inconsistency between the general conditions and the special conditions, the latter shall have precedence.

These special conditions, the general conditions, and the returnable schedules are only required for evaluation purposes, and shall not form part of any contract arising from the invitation to tender.

# **RFQ EVALUATION CRITERIA**

The 80/20 Preference Point System will be used as per the PPPFA and Buffalo City Metropolitan Municipality SCM policy.

All Bidders will be required to comply in terms of the following conditions, failing which such submitted bids will be deemed as non-responsive and disqualified without being considered in further evaluation.

- The project leader must be registered with the South African Geomatics Council (SAGC), in terms of Section 13 (4) (d) or otherwise approved by the SAGC in terms of the Geomatics Profession Act 2013, (Act No. 19 of 2013), and that the registration or such approval by the SAGC must remain effective throughout the tendering period and of the appointment.
- Proof of registration that the project leader is registered as a Geomatics Professional with the South African Geomatics Council (SAGC), in terms of Section 13 (4) (d) or otherwise approved by the SAGC in terms of the Geomatics Profession Act 2013, (Act No. 19 of 2013), and that the registration or such approval by the SAGC must remain effective throughout the tendering period and of the appointment.

The following criteria will also be used in the consideration of bid. Please note, a total of **70 POINTS** (out of total points of **100 POINTS**) is the minimum requirement for tender consideration in terms of functionality.

The purpose of the Functionality Assessment is to mitigate risk in terms of the bidder's ability to execute the projects, through the assessment of his/her experience in previously undertaking projects of similar nature.

Bidders are to submit the relevant information, failure to submit the relevant information will result in ZERO scores, which will result in the bid being eliminated from further consideration in the process.



- A. BCMM is intending to create a formal township, as part of its housing development initiatives. Therefore, it is necessary to prepare a General Plan to be approved by the Surveyor-General for the purposes of opening a Township Register with the Deeds Office.
- B. In order to ensure the registrability of the General Plan, it is required that the survey be carried in accordance to the regulatory framework, most importantly, the Land Survey Act 1997.
- C. Also, in accordance with the Geomatics Profession Act 2013, the appointed Service Provider shall be properly registered in the respective category (before and through the period of appointment), which reserves work performance of cadastral surveys to qualified practitioners.
- D. The total area covered by the subdivision is approximately ±1.66HA with a total of 54 Erven as shown on the attached layout plan.

# 2.3.1.4 SCOPE OF WORK

Buffalo City Metropolitan Municipality calls for the submission of bid proposals for the appointment of a company of Geomatics Practitioners to undertake a CADASTRAL SURVEY TO CREATE A SMALL-SCALE DIAGRAM AND GENERAL PLAN BY SUBDIVIDING FARM 1404 EAST LONDON, SITUATED IN MDANTSANE UNIT 5 (EKUPHUMLENI), IN ACCORDANCE WITH AN APPROVED LAYOUT. as detailed Below:

The work is to be carried out to the specifications as listed below:

# A. SCOPE OF WORK

- (i) In consultation and by prior arrangement and agreement with Geomatics Division the Land Surveyor shall subdivide Farm 1404 East London, situated in Mdantsane Unit 5 (Ekuphumleni) to create a Small-Scale Diagram and the associated General Plan thereof- see details on Annexure "A".
- (ii) All new boundaries that are intended to follow the proposed plan are to be surveyed accordingly.
- (iii) The appointed land surveyor will point out all final beacons of the new land parcels to relevant persons in consultation with the Geomatics Division.
- (iv) In the event of the land surveyor noting any serious anomalies or being in a position to make suggestions concerning the simplification of any procedures, he/she must communicate with the Geomatics Division.
- (v) The appointed land surveyor will be responsible for obtaining the necessary survey data and designations from the Surveyor-General's Office.
- (vi) The General Plan and Survey Records must be prepared in terms of the Land Survey Act No. 8 of 1997 (as amended) and the Regulations framed thereunder and submitted to the Surveyor General's Office for examination and approval.
- (vii) The appointed land surveyor is required to do all the necessary work in order to produce an approved General Plan which complies with the approved layout plan and consent.

# B. LAYOUT PLAN AND NUMBER OF ERVEN

- (i) The General Plan is to be fully beaconed and approved by the Surveyor-General.
- (ii) The land surveyor shall beacon the township according to the approved layout plan.
- (iii) The layout plan will be provided in both paper and electronic format (dxf).
- (iv) Minor deviations, not exceeding a maximum of 10 percent, shall be allowed from the approved layout plan.

- (v) Road widths are to be kept constant.
- (vi) Splays are required at each street corner or otherwise as indicated on the approved layout plan.
- (vii) The layout plan consists of a total number of 54 erven and a road.
- (viii) It is the duty of the land surveyor to check the exact number of erven to be surveyed as no extra compensation will be paid if the number quoted here is incorrect.
- (ix) Any servitude or other restrictive real rights that may be required to be surveyed must be surveyed in terms of the Land Survey Act, Act No. 8 of 1997 and Regulations promulgated thereunder.
- (x) All necessary closures of road/public place must be investigated by the appointed land surveyor and be carried out in accordance with the legislative requirements.

#### C. OUTSIDE FIGURE

- (i) The outside figure must be prepared and subdivided in accordance with the approved layout plan.
- (ii) The diagram of the outside figure must be submitted to the Surveyor-General, along with the respective General Plan, for approval.
- (iii) The tender should include the cost of surveying the outside figure/s including the cost of subdivisions and consolidations since the outside figure diagram does not exist.
- (iv) In some cases, where diagrams need to be withdrawn to reduce the cost of conveyancing, costs for such withdrawals much also be included in the tender. This needs to be clarified with BCMM before being finalized.

#### D. BUSH CLEARING

(i) The tender should include the cost of removing all obstructing bush and vegetation.

# E. BEACONS

- (i) All beacons must be erected in terms of the Land Survey Act, Act No. 8 of 1997 and Regulations promulgated thereunder
- (ii) All beacons are to be marked either with stones, battens or danger tape for easy identification.
- (iii) A beacon certificate is required to confirm that all beacons have been handed over to an official of the Geomatics Division of BCMM.
- (iv) Beacons should be 12mm x 400mm round iron pegs protruding at least 20mm above ground level.

(v) In places where 12mm x 400mm round iron pegs cannot be placed, suitable drill holes are to be made or other permanent makers that may be acceptable by the Surveyor-General's Office.

# F. RESOLUTION

(i) The appointed land surveyor is expected to report in writing, any problems encountered during the course of the survey.

# G. TIMELINES AND REPORTS

- (i) The survey should commence after the date of appointment and upon receipt of an instruction from the BCMM Geomatics Division.
- (ii) A monthly progress report should be emailed to the Geomatics Division.
- (iii) The survey should be completed and submitted to the Surveyor General's Office within 3 months of the date of appointment.
- (iv) Approved copies of the General Plan should be submitted to BCMM Geomatics Division within 6 months of the date of appointment.
- (v) This is an urgent project of the National Department of Human Settlements and any delay in obtaining the approval of the General Plan by the Surveyor General's Office after six months will be subject to penalty, provided that this delay is not attributed to any unforeseen circumstances, or caused by the BCMM, or caused by the community, etc. a monthly penalty of 2% will be deducted from the tender price for the late approval of the General Plan.
- (vi) In the event of a query or rejection by the Surveyor General's Office, the documents are to be re-lodged with the Surveyor General within a period of one week of such query or rejection.
- (vii) The BCMM Geomatics Division must be apprised of any of the above events.
- (viii) The deliverables referred to in Section L below are to be forwarded, as soon as they are available, to the Geomatics Division.

# H. CHARGES

- (i) Invoices must reflect VAT at 15%.
- (ii) Surveyor General's Office fees to be included in the tender.
- (iii) Transportation and professional fees are to be included in the tender.
- (iv) If the job is returned by the Surveyor General's Office, the laid down administration and reframe fees will be payable by the land surveyor.

#### I. PAYMENT MILESTONES

- (i) The invoice should be submitted to The Geomatics Division of BCMM, which will endorse it for payment.
- Seventy percent (70%) will be paid out upon submission of all the records required to the Surveyor General's Office in order to approve the small-scale and General Plan. The proof of submission must include the Surveyor General's Office acknowledgement letter.
- (iii) The balance of thirty (30%) percent will be paid out when the Geomatics Division of BCMM receives the certified copies of the approved diagram and General Plan.

# J. CONTIGENCIES

- i) Any amendments required to be done to the layout plan or any other contingencies should first be approved by BCMM before work can start.
- ii) The rate to be charged should comply with the rates determined in SAGC's recommended tariff.
- iii) The maximum amount of ten percent (10%) should be shown on the pricing schedule and this only implies that the amount will be kept in reserve and is not necessarily going to be paid out.

#### K. SUBCONTRACTING

i) No subcontracting will be allowed.

# L. DELIVERABLE AND TIMEFRAMES

- i) The successful tenderer will be granted 3 months to complete the survey.
- ii) Certified copy of the General Plan and the small-scale diagram approved by the Surveyor General's Office for registration purposes.
- iii) Beacon certificate duly signed by relevant representatives.
